The Road Commission of Macomb County will receive sealed bids for the following highway improvements until 11:00 A.M., Local Time, Tuesday, June 22, 2010, at the Road Commission offices, Macomb County Administration Building, 117 S. Groesbeck, Mount Clemens, Michigan 48043 at which time and place all bids will be publicly opened and read:

PROJECT DESCRIPTION

APPROXIMATELY, 18,800 TONS OF HOT MIX ASPHALT (HMA) PAVING, 31,500 FEET OF JOINT AND CRACK REPAIR, 700 TONS OF AGGREGATE BASE, 10,000 SQUARE YARD OF COLD MILLING EXISTING PAVEMENT, 13,500 SQUARE YARD (SYD) OF 7 INCH, 9 INCH AND 10 INCH NON-REINFORCED AND REINFORCED CONCRETE PAVEMENT REPAIR AND 28,500 FEET OF JOINT AND CRACK SEALING WITH RELATED GRADING AND DRAINAGE WORK ITEMS ON A NUMBER OF LOCATIONS, COUNTY WIDE, MACOMB COUNTY. THIS WORK CONSISTS OF MACHINE RESURFACING OF SHORT AREAS, RANGING FROM APPROXIMATELY 50 FEET TO 0.5 MILE IN LENGTH; AND, ONE, TWO, THREE, FOUR AND FIVE LANES IN WIDTH OF VARIOUS PRIMARY ROADS, LOCAL ROADS AND SUBDIVISION STREETS THROUGHOUT MACOMB COUNTY. THE APPLICATION RATE AVERAGES APPROXIMATELY 165 LB. PER SQUARE YARD. COLD MILLING OF JOINTS AND PAVEMENT REPAIR, BASE REPAIR, CURB, REMOVE AND REPLACE GRADING, TURF ESTABLISHMENT AND ADJUSTING DRAINAGE STRUCTURES AND PAVEMENT MARKINGS ARE ALSO A PART OF THIS WORK.

Plans and Specifications will be on file and will be available on or after Monday, May 24, 2010, at the Macomb County Administration Building, 117 S. Groesbeck, Mount Clemens, Michigan, upon payment of a \$30.00 fee **NON-REFUNDABLE.** Prospective bidders must have current prequalification with the Michigan Department of Transportation in the proper classification and numerical rating required for the work to be bid.

"NOTE: BIDS WHICH DO NOT COMPLY WITH THE FOLLOWING PREQUALIFICATION REQUIREMENT MAY NOT BE READ AT THE DISCRETION OF THE BOARD.

1. The prequalification rating shall be on file at the Road Commission of Macomb County, or shall be attached to the bid. However, a letter from the Department of Transportation may be accepted if the letter discloses that the prequalification rating with the Department of Transportation is extended, is currently in effect, and has not lapsed.

2. A contractor whose prequalifications have expired, and is unable to supply with the proposal a letter of extension from the Michigan Department of Transportation prequalification unit, as described in number 1 above, shall certify in writing that their prequalification has been extended by the Michigan Department of Transportation until such time as their new rating can be issued. Certification means a written, notarized affidavit under oath, setting forth facts (dates, times and individuals) which will serve to substantiate the contractor's claims of classification. If this certification does not accompany the bid, the Board in its discretion may elect not to read the bid."

A satisfactory Bid Bond, Certified or Cashier's Check, or bank Money Order, or Certificate of Deposit on an open, solvent bank, in the amount of not less than five (5%) percent of the total bid, payable to the Board of County Road Commissioners of the County of Macomb shall be submitted with each bid.

The Macomb County Road Commission at its discretion, reserves the right to reject any or all bids and to waive any irregularities in the bidding process, and to make the award as may appear to be in the best interest of the County of Macomb.

No bid may be withdrawn after the schedule closing time for receiving bids for at least forty-five (45) days. No proposal will be received unless made on blanks furnished by and delivered to the Road Commission of Macomb County on or before Tuesday, June 22, 2010, 11:00 A.M., Local Time.
