

**ADVERTISEMENT FOR BIDS FOR PRATT ROAD OVER SHAFER DRAIN  
AND 32 MILE ROAD OVER STONY CREEK  
TWO CULVERT REPLACEMENTS AND ONE CULVERT EXTENSION**

BIDS DUE: TUESDAY, SEPTEMBER 28, 2010, 11:00 AM EST

The Road Commission of Macomb County will receive sealed bids for the following highway improvements until 11:00 AM EST, on Tuesday, September 28, 2010, at the Road Commission of Macomb County Administration Building, 117 S. Groesbeck Highway, Mount Clemens, Michigan 48043 at which time and place all bids will be publicly opened and read:

PROJECT NO. 1250: BRIDGE REMOVAL AND REPLACEMENT WITH CONCRETE ELLIPTICAL PIPE, CIP HEADWALLS, AND RELATED APPROACH WORK IN TWO LOCATIONS ON PRATT ROAD OVER THE SHAFER DRAIN, RICHMOND TOWNSHIP, MACOMB COUNTY. MULTIPLATE PIPE-ARCH EXTENSION WITH RELATED APPROACH WORK ON 32 MILE ROAD OVER STONY CREEK, BRUCE TOWNSHIP, MACOMB COUNTY.

Plans and Specifications will be on file and will be available on or after Thursday, September 9, 2010, at the Road Commission Administration Building, upon payment of a \$30.00 NON-REFUNDABLE fee. Prospective bidders must have current prequalification with the Michigan Department of Transportation in the proper classification and numerical rating required for the work to bid.

NOTE: BIDS WHICH DO NOT COMPLY WITH THE FOLLOWING PREQUALIFICATION REQUIREMENT MAY NOT BE READ AT THE DISCRETION OF THE BOARD

1. The prequalification rating shall be on file at the Road Commission of Macomb County, or shall be attached to the bid. However, a letter from the Department of Transportation may be accepted if the letter discloses that the prequalification rating with the Department of Transportation is extended, is currently in effect, and has not lapsed.
2. A Contractor whose prequalifications have expired, and is unable to supply with the proposal a letter of extension from the Michigan Department of Transportation prequalification unit, as described above, shall certify in writing that their prequalification has been extended by the Michigan Department of Transportation until such time as their new rating can be issued. Certification means a written, notarized affidavit under oath, setting forth facts (dates, times and individuals) which will serve to substantiate the contractor's claims of classification. If this certification does not accompany the bid the Board in its discretion may elect not to read the bid.

NET CLASSIFICATION: 400 Fa Sub Ea

A satisfactory Bid Bond, Certified or Cashier's Check or Bank Money Order, or Certificate of Deposit on an open, solvent bank, in the amount of not less than five (5%) percent of the total bid, payable to the Board of County Road Commissioners of the County of Macomb shall be submitted with each bid.

The Road Commission of Macomb County at its discretion, reserves the right to reject any or all bids and to waive any irregularities in the bidding process, and to make the award as may appear to be in the best interest of the County of Macomb.

No bid may be withdrawn after the schedule closing time for receiving bids for at least forty-five (45) days. No proposal will be received unless made on blanks furnished by and delivered to the Road Commission of Macomb County on or before Tuesday, September 28, 2010, 11:00 AM EST.
